9 **Under penalty of perjury, I swear or affirm that the information in this declaration**  
10 **is true and that I understand my rights and obligations regarding return of the firearms I**  
11 **have surrendered to the law enforcement agency:**

12 I am aware of the Court's Order to Surrender Firearms. I have elected to surrender my  
13 firearms to the law enforcement agency indicated. All firearms that I own, have possession of, or  
14 right of control over are listed in Exhibit A, attached to and made part of this declaration. All of  
15 the firearms in Exhibit A have been surrendered to the law enforcement agency. As proof I have  
16 attached a copy of the law enforcement agency receipt or property in custody report. I understand  
that if I have failed to identify and surrender each and every one of the firearms subject to the  
court's order, that I may be prosecuted for perjury and subject to contempt of court.

17 I understand that it is my obligation to obtain a Court Order Authorizing Return of  
18 Firearms within 60 days after the expiration or termination of the protective order at issue. I  
19 understand that I must make a request in writing to the court to schedule a Firearms Return  
20 Hearing to obtain the court's permission to return the firearms to me, and that I must personally  
21 appear at that hearing. *I understand that if I fail to obtain a court order returning the firearms to  
me in the time allowed, that the firearms will be deemed abandoned by me without further  
notice.*
