10 **Under penalty of perjury, I swear or affirm that the information in this declaration is**
11 **true and that I understand my rights and obligations regarding return of the firearms I have**
12 **transferred to a third party:**

13 I am aware of the Court's Order to Surrender Firearms. I have identified all the firearms
14 subject to the Court's order in Exhibit A, which is attached to and made a part of this declaration.

15 I do not own or possess or otherwise control any other firearms that are not listed in Exhibit
16 A. I have elected to transfer my firearms to the third party named in Exhibit A. I understand that I
17 cannot have access to any firearms, and I will not attempt to access, possess or exercise control over
18 these firearms or any other firearms until further order of the court. I understand that if I have failed
19 to identify and transfer each and every one of the firearms subject to the court's order, that I may be
20 prosecuted for perjury and subject to contempt of court.

21 I understand that it is my obligation to obtain a Court Order Authorizing Return of Firearms
22 within 60 days after the expiration or termination of the protective order at issue. I understand that I
23 must make a request in writing to the court to schedule a Firearms Return Hearing to obtain the
24 court's permission to return the firearms to me, and that I must personally appear at that hearing.
