Oregon State Bar Attorney Referral Service: 1-800-452-7636 (toll free)

Can give you legal advice, represent you in court, and prepare legal documents for you. You can hire them to handle your case, or you can pay them for a consultation. Attorney referral information is available through the Oregon State Bar.

Oregon State Bar Modest Means Program: 1-800-452-7636

Provides attorney services for people who make too much money to qualify for Legal Services but who cannot afford to pay the full cost of attorney services. They also provide limited services through the Pro Se Assistance Panel for couples who are getting divorced when both spouses agree on all issues.

Legal Aid (Center for Non-Profit Legal Services): 541-779-7292

Represents low income clients in a number of kinds of cases including divorces, custody or visitation disputes, evictions, social security disputes and immigration, as well as some others. They are located at 225 W. Main, Medford, Oregon.

Paralegal Services:

Legal document services and some paralegals sell do-it-yourself kits for legal documents, and for an additional fee, will prepare the documents for you. They cannot give legal advice or represent you in court. (See paralegals in yellow pages)

Stationary and Office Supply Stores:
