**2. FINDINGS:**

▶ Aggravated Circumstances exist pursuant to ORS 419B.340. Those circumstances are based on one or more of the following facts:

- Mother  Father has caused the death of any child by abuse or neglect. ORS 419B.340(5)(a)(A).
- Mother  Father has attempted, solicited or conspired, as described in ORS 161.405, 161.435, 161.450 or under comparable laws of any jurisdiction, to cause the death of any child. ORS 419B.340(5)(a)(B).
- Mother  Father by abuse or neglect has caused serious physical injury to any child. ORS 419B.340(5)(a)(C).
- Mother  Father subjected any child to rape, sodomy or sexual abuse. ORS 419B.340(5)(a)(D).
- Mother  Father has subjected any child to intentional starvation or torture. ORS 419B.340(5)(a)(E).
- Mother  Father has abandoned the child as described in ORS 419B.100(1)(e). ORS 419B.340(5)(a)(F).
- Mother  Father has unlawfully caused the death of the other parent. ORS 419B.340(5)(a)(G).

▶ Prior Convictions under ORS 419B.340(5)(b).  Mother  Father has been convicted of the following crimes:

- Murder of another child of the parent, which murder would have been an offense under 18 USC 1111(a).
- Manslaughter in any degree of another child of the parent, which manslaughter would have been an offense under 18 USC 1111(a).
- Aiding, abetting, attempting, conspiring or soliciting to commit an offense of murder of another child or Manslaughter in any degree of another child that would be an offense under 18 USC 1111(a).
