*To use these forms you must be at least 18 years of age  
and your child must be a resident of Multnomah County.*

**CHANGING THE NAME OF A MINOR:**

Changing the legal name of a minor can be a simple process if no one objects to the change. The following are the steps involved:

- (1) Appointing an adult as Guardian Ad Litem for the minor, by seeing a judge and having an order signed,
- (2) Posting a public notice of the proposed name change in the Courthouse for at least 30 days,
- (3) Personally serving the “other parent” (or both parents if the Guardian Ad Litem is not a parent) if involved,
- (4) Appearing briefly before a judge who will sign the name change judgment,
- (5) Publicly posting notice of the name change so the new name becomes official

**FEES**

The charge for the forms provided at the courthouse is \$1.25. The court fee for filing a name change petition is \$111.00. There is a \$5.00 charge for one certified copy of your general judgment of name change.

## **INSTRUCTIONS**

Please read all instructions carefully. **DO NOT FILL OUT ALL THE FORMS AT ONCE. YOU WILL NEED TO COMPLETE THE FORMS AS YOU COMPLETE THE STEPS FOR A NAME CHANGE.** These are legal documents that must not contain mistakes. Do not alter the documents.

### **(First Visit to Courthouse)**

#### STEP 1:

- A. Fill out the Application for Appointment of Guardian Ad Litem for Name Change of a Minor (Form 1)
- B. Fill out Order for Appointment of Guardian Ad Litem for Name Change of a Minor (Form 2) **Please type or print clearly.**

**STOP: DO NOT FILL OUT ANYMORE FORMS AT THISTIME. FOLLOW THE INSTRUCTIONS.**

#### STEP 2:

- A. **Sign Form 1 in front of Family Law Clerk**, located in Room 211 of the Multnomah County Courthouse.  
Bring with you **one** form of valid photo identification – a current, state-issued driver’s license or identity card; current passport; current U.S. military identification card; current identity card issued by federally recognized tribe; or another current, government-issued document containing your photograph, signature, and physical description.
- B. Check with Family Law Clerk to determine which Judge is handling Ex Parte. Ex Parte is held Monday-Friday at 8:30AM and 1:30PM. **You cannot file your case until you have been appointed the child’s Guardian Ad Litem** (guardian for purposes of the legal case). Judges are available at 8:30AM and 1:30PM daily to hear your request, so plan your trip to the courthouse appropriately around these times.
- C. Present Form 1 & Form 2 to the Judge at Ex Parte time for his/her signature. The judge will give you back your paperwork and instruct you to return to Room 211 for further processing of your name change.

#### STEP 3:

- A. Fill out the **PETITION FOR NAME CHANGE OF A MINOR** (Form 3)  
Please type or print.

**STOP: DO NOT FILL OUT ANYMORE FORMS AT THIS TIME.**

**FOLLOW THE INSTRUCTIONS.**

- B. **Sign Form 3 in front of the Family Law Clerk**, located in Room 211 of the Multnomah County Courthouse. (Make sure you bring one form of photo identification). **Ask Family Law Clerk to make you one copy of Form 3.**
- C. Go to the cashier, located in Room 210 of the Multnomah County Courthouse. Pay the \$1.25 form fee and the \$111 court filing fee and \$5.00 copy fee. Obtain a case number from the cashier, making sure the cashier puts the case number on all eleven forms.

STEP 4:

- A. Complete **NOTICE OF NAME CHANGE HEARING** (Form 4). Leave the following spaces blank: hearing date & time of hearing
- B. Take Form 4 back to Room 211. Use the telephone on the table and dial 83185. Ask for a Name Change hearing date for a **MINOR.**
- C. Fill in the hearing date on Form 4. **Ask the Family Law Clerk to make you one copy of Form 4.**
- D. Post Form 4 on the **IDENTITY CHANGE POSTINGS** bulletin board in Room 211. This form must remain posted for **at least thirty full days prior to the hearing.**

**You now need to decide which method of service you will be using to serve the “other parent” or “legal guardian,” or both parents if you are not a parent of the child. Below are options for service. For more information on service see ORCP 7.**

**The “other parent” or “legal guardian” must receive a “true copy” of Form 3 & Form 4 and you must show “proof of service” to the court that the “other parent” or “legal guardian” received the copies.**

**Personal Service:**

**You cannot** personally serve the “other parent” or “legal guardian.” Service must be done by someone at least 18 years old, who is not a party to the suit, nor an attorney or employee of yours. With the copies of Form 3 & Form 4, you may request the County Sheriff’s office to personally serve the “other parent” or “legal guardian”. If the “other parent” or “legal guardian” lives in Multnomah County, our Sheriff can serve your papers. The fee for this is \$36.00 and you can pay the cashier in Room 210 and the cashier will forward your papers to the sheriff.

If the “other parent” or “legal guardian” lives in any other county or any other state, and you want the sheriff to do service for you, it is your responsibility to contact the sheriff’s office in that county or state and find out what their procedure and fees are for service.

**3<sup>rd</sup> Party Service:**

You can also have a friend (at least 18 years old) or a private process server serve Form 3 &

Form 4 on the “other parent” or “legal guardian.” If this is the option you choose, ask the Family Law Clerk in Room 211 for a “3<sup>rd</sup> Party service packet” and follow the instructions in the packet.

### **Certified Mail: (FORM 11)**

You can also use Certified Mail, Return Receipt Requested, to send Form 3 & Form 4 to the “other parent” or “legal guardian.” This will work only if the “other parent” or “legal guardian” is willing to sign the return receipt. Attach the signed receipt (green card from the post office) to Form 11 (Proof of Mailing), fill out Form 11, and file it with the Family Law Clerk in Room 211. If the “other parent” or “legal guardian” will **not** sign the return receipt, you must arrange for personal service. **If you use this certified mail method, you must add an additional three days to the thirty day posting period. This is required by Oregon Rule of Civil Procedure 10 C. This means you must schedule your hearing at least 33 days out instead of thirty days out.**

### **Consent of “Other Parent” or “Legal Guardian” (FORM 10)**

If the “other parent” or “legal guardian” voluntarily agrees to the Name Change, the “other parent” or “legal guardian” can complete Form 10. That person must sign Form 10 in front of a notary. The form must then be returned for filing with the Family Law Clerk in Room 211. (If the “other parent” or “legal guardian” lives in Multnomah County, he or she can come to Room 211 and have the Family Law Clerk notarize the signature with proper identification).

### **Waiver of Written Notice to Other Parent, pursuant to ORS 33.420 (3) (FORM 9)**

If the other parent has **NEVER** resided with the minor child and has **never** tried to contribute to the financial support of that child, you may fill out Form 9 and have the Family Law Clerk in Room 211 notarize your signature. You must be a parent (as opposed to a legal guardian) to qualify to fill out Form 9.

### **(Second Visit to Courthouse-on the Hearing Date)**

STEP 5:

- A. Remove Form 4 (NOTICE OF NAME CHANGE HEARING) from the bulletin board in Room 211.
- B. Complete Form 5 (AFFIDAVIT OF POSTING NOTICE OF NAME CHANGE HEARING) and sign it in front of the Family Law Clerk in Room 211. Remember to bring proper identification with you, for this purpose.

STEP 6:

- A. Complete Form 6 (GENERAL JUDGMENT). Leave the following spaces blank: Judge’s signature line and date. At the hearing, the Judge will decide whether to sign. **This form must be completed before you go to your hearing.** Take Forms 4, 5, and 6 to the court hearing.

- B. The Family Law Clerk in Room 211 will direct you to the appropriate courtroom. After your court hearing, the judge will keep Forms 4, 5, and 6 and instruct you to return to Room 211 to complete the process.

STEP 7:

- A. After your hearing, complete Form 7 (NOTICE OF GENERAL JUDGMENT OF NAME CHANGE).
- B. Post Form 7 on the Identity Change Postings bulletin board in Room 211. (The board is clearly marked).
- C. Fill out Form 8 (AFFIDAVIT OF POSTING NOTICE OF GENERAL JUDGMENT). Sign this in front of the Family Law Clerk in Room 211. Remember to bring proper valid photo identification with you for this purpose. The Family Law Clerk will keep Form 8 and file it with the court. **IF YOU WANT MORE THAN ONE COPY OF YOUR GENERAL JUDGMENT, PAY THE COURT CASHIER FOR THEM. EACH CERTIFIED COPY IS \$5.00.**

**(After Leaving the Courthouse)**

- A. You can use a certified copy of your General Judgment of Name Change as official proof of the change for public agencies or as you might otherwise need.

Providing a copy to The Center for Health Statistics , P.O. Box 14050, Portland, OR 97239-0050, to change your birth certificate will be useful only if you were born in Oregon. If you were born in another state, you will need to contact that state to find out that state's requirements. Oregon Vital Statistics website info is available at:
