What you need to do: Call and make an appointment for a specific date and time.

What you must bring: Marriage License, Certificate and at least 2 witnesses (18 yrs. old or older)

****Fee requirements:** ORS 106.120(4)(a) requires a fee payment of \$105.00, for a marriage solemnized by Judge. This fee must be paid prior to the wedding. Please ask the judge's office where to pay this fee, when scheduling the wedding. In addition to the \$105.00 fee, there is a \$100.00 fee payable to the Judge for weddings solemnized after the regular court hours (i.e. 5:00 PM) and/or outside chambers.
