<b>FELONIES</b>	<b>MISDEMEANORS</b>
Class A – 20 years	Class A – 1 year
Class B – 10 years	Class B – 6 months

**HOMICIDE**

<b>Manslaughter 1</b>	<b>Reckless, intentional &amp; emotional disturbance</b>	<b>Class A felony</b>
<b>Manslaughter 2</b>	<b>Reckless, aids in suicide</b>	<b>Class B felony</b>
<b>Criminally Negligent Homicide</b>	<b>Criminal negligence causes death</b>	<b>Class C felony</b>

**FAMILY CRIMES**

<b>Incest</b>	<b>Sexual intercourse with family member</b>	<b>Class C felony</b>
<b>Abandonment</b>	<b>Deserts child under 15</b>	<b>Class C felony</b>
<b>Child neglect 2</b>	<b>Child under 10</b>	<b>Class A misdemeanor</b>
<b>Child neglect 1</b>	<b>Child under 16; controlled substances delivered or manufactured</b>	<b>Class B felony</b>
<b>Criminal nonsupport</b>	<b>Fails to pay child support</b>	<b>Class C felony</b>
<b>Endangering welfare of a minor</b>	<b>Permits under 18 to witness sex, masochistic abuse, remain where controlled substances are present, etc.</b>	<b>Class A misdemeanor or fine not below \$100. or more than \$500</b>

**THEFT**

<b>Theft 3</b>	<b>Value under \$50</b>	<b>Class C misdemeanor</b>
<b>Theft 2</b>	<b>Receiving is \$50 or more but under \$200; and under \$750 in other</b>	<b>Class A misdemeanor</b>
<b>Theft 1</b>	<b>Receiving is \$200 or more and \$750 and over for other</b>	<b>Class C felony</b>
<b>Aggravated theft 1</b>	<b>Value \$10,000 or more</b>	<b>Class B felony</b>
<b>Unlawful use of a vehicle</b>	<b>Takes or uses vehicle without consent</b>	<b>Class C felony</b>

**BURGLARY AND CRIMINAL TRESPASS**

<b>Burglary 2</b>	<b>Unlawfully enters a building with intent to commit a crime</b>	<b>Class C felony</b>
<b>Burglary 1</b>	<b>Unlawfully enters a building and is armed or threatens harm or causes harm</b>	<b>Class A felony</b>
<b>Criminal trespass 2</b>	<b>Enters or remains unlawfully</b>	<b>Class C misdemeanor</b>
<b>Criminal trespass 1</b>	<b>Reenters building with intent to commit theft</b>	<b>Class A misdemeanor</b>

**ARSON**

<b>Arson 2</b>	<b>Intentionally causes damage</b>	<b>Class C felony</b>
<b>Arson 1</b>	<b>Intentionally causes damage and hurts others</b>	<b>Class A felony</b>
<b>Reckless burning</b>	<b>Causes damage</b>	<b>Class A misdemeanor</b>

**CRIMINAL MISCHIEF**

<b>Criminal mischief 3</b>	<b>Intentional causes substantial inconvenience to other</b>	<b>Class C misdemeanor</b>
<b>Criminal mischief 2</b>	<b>Intentionally causes over \$100 of damage</b>	<b>Class A misdemeanor</b>
<b>Criminal mischief 1</b>	<b>Intentionally causes over \$500 of damage or starts a fire in an institution lives in (sic)</b>	<b>Class C felony</b>

**ROBBERY**

<b>Robbery 3</b>	<b>Theft while using or threatening physical force</b>	<b>Class C felony</b>
<b>Robbery 2</b>	<b>Theft with dangerous or deadly weapon present</b>	<b>Class B felony</b>
<b>Robbery 1</b>	<b>Theft with armed deadly weapon; causes or threatens serious physical injury</b>	<b>Class A felony</b>

**FORGERY**

<b>Forgery 2</b>	<b>Falsify a written instrument</b>	<b>Class A misdemeanor</b>
<b>Forgery 1</b>	<b>Falsify a written instrument related to money</b>	<b>Class C felony</b>
<b>Fraudulent use of a credit card</b>	<b>Unlawfully uses a credit card</b>	<b>Class A misdemeanor if under \$750; Class C felony if over \$750</b>
<b>Negotiating a bad check</b>	<b>Knowingly writes bad check</b>	<b>Class A misdemeanor – most</b>
<b>Misrepresentation of age by a minor</b>	<b>Lies about age for benefit</b>	<b>Class C misdemeanor</b>

**DISORDERLY CONDUCT AND INTIMATION**

<b>Disorderly conduct</b>	<b>Causes inconvenience, annoyance or alarm</b>	<b>Class B misdemeanor</b>
<b>Harassment</b>	<b>Harasses or annoys others</b>	<b>Class B misdemeanor</b>
<b>Intimidation 2</b>	<b>Causes damage due to prejudice against person</b>	<b>Class A misdemeanor</b>
<b>Intimidation 1</b>	<b>Two or more others commit intimidation 2</b>	<b>Class C felony</b>

**POSSESSION AND USE OF WEAPONS**

<b>Unlawful use of weapon</b>	<b>Unlawfully carries or uses a deadly weapon</b>	<b>Class C felony</b>
<b>Carrying of concealed weapon</b>	<b>Carrying a knife or other dangerous object</b>	<b>Class B misdemeanor</b>
<b>Unlawful possession of firearms</b>	<b>Carrying a concealed gun or is not allowed to possess gun</b>	<b>Class A misdemeanor</b>

**PROSTITUTION**

<b>Prostitution</b>	<b>Engages in or offers sex for \$</b>	<b>Class A misdemeanor</b>
<b>Promoting prostitution</b>	<b>Operates prostitution business</b>	<b>Class C felony</b>
<b>Compelling prostitution</b>	<b>Uses force to compel others to prostitute; induces under 18 to</b>	<b>Class B felony</b>

**SEX CRIMES**

<b>Rape 3</b>	<b>Victim under 16</b>	<b>Class C felony</b>
<b>Rape 2</b>	<b>Victim under 14</b>	<b>Class B felony</b>
<b>Rape 1</b>	<b>Forcible compulsion &amp; victim under 12; victim &gt;16 &amp; is sibling (whole or half) child or spouses child</b>	<b>Class A felony</b>
<b>Sodomy 3</b>	<b>Deviate sexual intercourse, victim under 16</b>	<b>Class C felony</b>
<b>Sodomy 2</b>	<b>Deviate sexual intercourse. Victim under 14</b>	<b>Class B felony</b>
<b>Sodomy 1</b>	<b>See rape – deviate sexual intercourse</b>	<b>Class A felony</b>
<b>Unlawful sexual penetration in second degree</b>	<b>Penetration with other object, victim under 14</b>	<b>Class B felony</b>
<b>Unlawful sexual penetration in first degree</b>	<b>Penetration with other object, victim under 12</b>	<b>Class A felony</b>
<b>Sex abuse 3</b>	<b>Submits to sexual contact</b>	<b>Class A misdemeanor</b>
<b>Sex abuse 2</b>	<b>Sexual intercourse, deviate sexual intercourse or penetration of other object</b>	<b>Class C felony</b>
<b>Sex abuse 1</b>	<b>Victim under 14, causes person under 18 to touch animal</b>	<b>Class B felony</b>
<b>Sexual misconduct</b>	<b>Sexual misconduct with victim under 18</b>	<b>Class C misdemeanor</b>
<b>Public indecency</b>	<b>Sexual intercourse or exposing oneself</b>	<b>Class A misdemeanor</b>

**ASSAULT AND RELATED OFFENSES**

<b>Assault 3</b>	<b>Reckless</b>	<b>Class C felony</b>
<b>Assault 2</b>	<b>Intentional or knowingly</b>	<b>Class B felony</b>
<b>Assault 1</b>	<b>Intentional and deadly weapon</b>	<b>Class A felony</b>
<b>Menacing</b>	<b>By word or conduct intentionally place another in fear of imminent serious physical injury</b>	<b>Class A misdemeanor</b>
<b>Reckless endangering</b>	<b>Reckless engages in conduct which creates substantial risk of serious physical injury</b>	<b>Class A misdemeanor</b>
<b>Criminal mistreatment 2</b>	<b>Withholds food, physical care or medical attention</b>	<b>Class A misdemeanor</b>
<b>Criminal mistreatment 1</b>	<b>Causes physical injury, abandons, takes or misuse money</b>	<b>Class C felony</b>

**KIDNAPPING AND RELATED OFFENSES**

<b>Kidnapping 2</b>	<b>Takes a person or secretly confines them</b>	<b>Class B felony</b>
<b>Kidnapping 1</b>	<b>Takes a person and compels ransom, hostage, terrorizes or cause physical injury</b>	<b>Class A felony</b>
<b>Custodial interference 2</b>	<b>Violates a joint custody</b>	<b>Class C felony</b>
<b>Custodial interference 1</b>	<b>Violates joint custody and exposes person to harm</b>	<b>Class B felony</b>
<b>Coercion</b>	<b>Compels or induces a person to act illegally or threatens them with harm to act</b>	<b>Class C felony</b>
