The 2009 JCIP Road Show is coming! Please see the schedule below for dates and locations. Topics will include: new legislation (including the federal Fostering Connections to Success & Increasing Adoptions Act of 2008); structured decision-making for child safety; relative placements, and more. This year, JCIP and DHS will be joined by the newly created Juvenile Law Resource Center (JLRC), a joint project of the Office of Public Defense Services and the Juvenile Rights Project. The JLRC will be presenting an afternoon session for attorneys whose practice includes at least some representation of parents. DHS will be presenting an afternoon session for DHS, CRB, CASA's, and other stakeholders.

Due to funding limitations, the road shows will be held in a limited number of regions this year. The schedule below provides the targeted regions with the specific location for the training underlined. Participants can register for a date/location outside of their targeted region if necessary.
