

Access to Case Information for Clackamas County Circuit Court Changes on December 1, 2015!



A new electronic case management system – the **Oregon eCourt Case Information system (OECI)** – is being installed in Clackamas County Circuit Court beginning **Tuesday, December 1, 2015 at 5:00 pm through 8:00 am Monday, December 21, 2015.**

During this time, Clackamas County Circuit Court case information entered after December 1, 2015 at 5:00 pm **will not be available at courthouse public access terminals, nor to online subscribers.** Case data for this court entered from December 1 at 5:00 pm to December 21 before 8:00 am can be accessed by requesting it at the court clerk's counter, Monday through Friday. **Please check the local court website (<http://courts.oregon.gov/OJD/courts/pages/index.aspx>) for hours of operation, as public counter access hours may vary by courthouse location.**

There will be short periods of downtimes of remote online services in the twenty-six circuit courts currently using the Oregon eCourt Case Information system, as well as in Clackamas County Circuit Court, to allow for the accurate and efficient migration of Clackamas data into the OECI system.

The OJD [eFiling](#) homepage and portal will have a separate notice. Call your local court to check public access terminal availability before traveling to the courthouse.

On **Monday, December 21, 2015**, all Clackamas County Circuit Court case information can be accessed by the public at most public courthouse terminals, or by [OJCIN OnLine](#) subscribers through the **Oregon eCourt Case Information system (OECI)**. Some Oregon circuit courts may not have public terminal access to the new system. In that case, the public can request case information for Clackamas County Circuit Court at the court clerk's counter in the circuit courthouse for their county.

During the installation of the new system, all Clackamas County Circuit Court case information that was entered into the system **before December 1 at 5:00 pm, remains available and accessible** to the public and OJCIN subscribers through the Oregon Judicial Information Network (OJIN) and will remain available in that case management system until **Saturday, January 16, 2016, when it will be removed from OJIN and archived.** At that time, Clackamas data will no longer appear in OJIN and all case data (past and present) for this court will be accessed through the new OECI system. All other Oregon circuit courts that have not been converted to the OECI system will continue to provide public and OJCIN OnLine subscriber access to case information through the OJIN system until they transition to OECI.

Following the Clackamas County Circuit Court Go-live in December, Washington County Circuit Court and the Oregon Tax Court will implement the new system in March 2016. The rest of Oregon's circuit courts are scheduled for implementation in June of 2016. Public notice will be provided in advance of coming implementations.
