Welcome to your Multnomah Circuit Court virtual jury service. Jury selection will take place online using a video conferencing application called Webex Meetings. Please do not come to the courthouse unless you've planned with a court clerk.

During your virtual jury selection, you'll be able to see and hear other people, and other people will be able to see and hear you. To prepare for your service, have your Juror Panel Number, which is located in your jury duty email. Thank you for serving!

You can join a Webex Meeting from your computer, tablet, or smartphone. Your device needs to be equipped with a camera, microphone, and internet connection. Choose the one that works best for you.

Join from a Windows, Mac, or Chromebook Computer

1. Open your email invite sent by the court and click **<u>Click Here to Start Meeting</u>**.

2. Click **<u>Open Webex</u>** if you're prompted to do so, otherwise click **<u>Launch Meeting</u>**.



3. Enter your **Panel Number** from the email the court sent you. Enter your **Email Address**. Click **Join as Guest.**

 Tap OK.
- Tap the microphone icon to Unmute your mic. Tap the video icon to turn on your video. Tap Join.
