

## JUROR INFORMATION SHEET

**1. Response Form:** Please read this information and then complete and sign the enclosed juror eligibility form and mail it as soon as possible. The Court must receive this form no later than one week before your service starts. Postage on the enclosed return envelope is prepaid. Please mail the form back as soon as possible.

**2. Where to Report and Telephone, FAX and Mailing Address:** You are to report, and send any mail regarding this summons, to the following address: Jury Assembly Room, Room 130, Multnomah County Courthouse, 1021 SW 4<sup>th</sup> Avenue, Portland, Oregon 97204.

**3. Persons with Disabilities:** The court will provide ADA accommodation upon request of jurors with disabilities. If you have a disability, please tell the jury coordinator what accommodations you need. Any person who has a hearing disability and needs an accommodation in order to participate in jury service may notify the Circuit Court of the disability and the need for sign interpreters or assistive hearing devices by checking the boxes in Section 3 of the response form. You may also contact the Court by telephone, TDD, fax or letter regarding assistance. The jury room TDD number is 503.988.3907.

**4. Daily Hours:** On Monday or Wednesday, on your first day of service, you must report by 8:00 AM. The Courthouse opens at 7:00 AM and the jury assembly room opens at 7:30 AM for new jurors to be enrolled. The business day ends at 5:00 PM. On your second day of service or, if you are selected to sit on a trial, subsequent days' hours will be set by the Court. Occasionally, a trial may run past 5:00 PM.

**5. Courthouse Security:** It is a Class C felony (5 years prison, \$10,000 fine or both) for any person to intentionally possess a weapon, including a loaded or unloaded firearm, in a court facility (ORS 166.370). This prohibition against carrying a handgun or any other weapon will be enforced by the Multnomah County Sheriff. "Airport" type screening is required to enter the court facility. Pocket knives, leatherman tools, knitting needles or other pointed or sharp items are not allowed in the courthouse. Court security staff will NOT hold unauthorized items for return to jurors at the end of the day.

**6. Duration of Service:** Your service is for two days. If you are selected for a trial which goes beyond two days, your service extends to the end of the trial. You may sit on more than one trial in the two day period. If you are selected for a grand jury (a small number of individuals may be selected for these), your service will be for one month.

**7. Delaying Service to Another Time:** You may request service to be delayed to start no later than one year from your original service date. If you wish to request a deferral to a future jury service date, you may make your request by indicating your preferred new date in Section 3 on the response form or you may request a deferral by telephone, fax or letter. You will receive a confirmation card in the mail and will receive a reminder jury summons about a month before your new jury service begins.

**8. Getting Excused From Service - Mandatory Standards to be Excused:** The Court has no discretion if you are age 70 or older on the date of jury service or if you are a woman breast feeding a child and you request to be excused. If you want to serve as a juror, you may serve; complete the response form and mail it. If you want to be excused, then check the box provided in Section 3 on the response form, sign and return the form. You may also make the request to be excused by telephone (age 70 only), fax or letter.

**9. Getting Excused From Service - Discretionary Standards to be Excused:** In its discretion, the Circuit Court may excuse jury service if: (a) the jury service causes you, your family or your employer undue hardship or extreme inconvenience; or, (b) you are the sole care giver for a child or other dependent and you attend personally to the dependent during the court's normal hours of operation and you are unable to afford daycare or make other arrangements for the care of the dependent. If you request to be excused under these standards, the Court will weigh the basis for your excuse against the public's need for jurors. The Court may deny a request under (a) or (b), above, and require you to serve.

**10. How to Request To Be Excused Based on Discretionary Standards:** You may make the request by telephone, fax or mail. If your request is in writing, please explain the nature of the condition, undue hardship or extreme inconvenience which requires you to be excused. Please include your juror number (indicated on the top of your summons), a return address, and a contact phone number in any written communication. The Court will mail you a notice of its decision on your request to be excused. If your request is denied, then you must serve. Mail the completed juror response form to the Court or bring it with you when you report for service.

**11. The deadline for requesting to be excused or to delay jury service is one week before your service begins.**

**12. Parking Facilities:** No parking is provided. If you drive, parking is your responsibility. We strongly recommend that you take Tri-Met. Parking downtown is very expensive and scarce.

**13. Juror Pay:** Compensation is set by the Oregon Legislature. By law, a juror must waive the daily fee if the juror is paid a wage or a salary by the juror's employer for the days of jury service, unless, otherwise provided by an employment agreement. If the daily fee is paid, it is paid at the following rate: Days 1 and 2, \$10 per day; Day 3, and beyond, \$25 per day. Juror travel expense for each day of service will be compensated in one of two ways: (1) take Tri-Met, the cost of Tri-Met tickets will be paid regardless of the distance; or, (2) \$.20 per mile round trip. All payment is sent by mail.

**14. Hazardous Weather:** If there are hazardous weather conditions on the day you are to report for jury service, call 503.988.3170 or check the Circuit Court web page for instructions.

**15. Computer and Cell Phone Usage:** Computer and cell phone usage is allowed in the jury assembly room. The room has internet connections available (dial-up, broadband and wireless). Cell phones and computers are run through an x-ray scanner during the security screening process.
