#### 4. CIP Project Discussion—JCIP-ODHS Safety Question Project

a. Review & feedback on draft questions
Jayne Cooper: reviews questions, members sent to breakout
rooms to discuss. Questions will be discussed at the Model Court
Summit.

*Judge Perez*: questions should be asked in the shelter report, ready for court.

Joanne Southey: barrier may be that different terms are being used.

*Judge Love*: flexibility to use verbiage that sets the tone for rest of hearing.

Maggie Carlson: integration about what the specific harm will be to a particular child.

#### 5. Child and youth representation on appeal—a look at what's happening

Jayne Cooper: Concern brought forward about children not being represented on appeal and requested data about how often that has been happening. Data shown reflecting frequency of child present at appeal. Quality legal representation is a priority for JCIP.

Judge Love: Most cases where child had an attorney were affirmed on appeal, child's attorney had to request for appellate counsel.

Joanne Southey: DOJ has seen the child not represented on appeal frequently and has questions as well. Processes to represent children on appeal have been challenging and infrequent.

Christa Obold-Eshleman: Form needs to be filled out by trial attorney to obtain child attorney on appeal. Not sure why that hasn't been happening as often as it should.

Justice Ortega: Does not see many cases where children are represented on appeal, not sure what might be missing since cases are low for representation. Concerned about neither DOJ nor parent attorney requesting appellate counsel due to differing perspectives.

#### 6. CRB Data Project

Christina Jagernauth: draft data documents sent to members which came from CRB's 3-year strategic plan. Ten measures were collected over the last eight months and would like to continue collecting the data for each case that is reviewed and report the information quarterly.
