

Clackamas County Circuit Court Jury Service during the Coronavirus Pandemic

Clackamas County Circuit Court is committed to maintaining access to services while keeping jurors, litigants, staff, the public and others safe. Jurors perform a vital role in our American system of justice. Jury service is an important civic function that supports one of the fundamental rights of citizens—the right to have their cases decided by a jury of their peers. The right to a speedy trial is important for every single Oregon citizen accused of a crime, even when in the midst of a pandemic. Because of that constitutional right we have a new process for calling in jurors to the courthouse that includes changes that have been made for the safety and protection of all jurors.

Some of those changes are:

- Jury panels are being called in small groups of no more than 25 jurors in one room, and 6 feet of social distancing is maintained at all times.
- Face coverings are required at all times for jurors, court staff and others in the courthouse.
- Jury rooms and items used by jurors (pens, clipboards, chairs etc.) are being disinfected after each session. This also includes door knobs and countertops.
- Hand sanitizer is available at multiple locations.
- There are markings throughout the space indicating where to stand or sit so that we can ensure that there is adequate social distancing.
- Should you be placed on a panel and be sent to a courtroom, jurors are sent over in small groups of no more than 10, and once in the courtroom are spaced out that we can ensure social distancing. In addition, because our jury rooms are not large enough for the jury panel, we have designated a second courtroom for the use of jurors during deliberation.

Feeling III or You or Household Member at Higher Risk

Potential jurors who are ill or in "higher risk" or "others at risk" categories (as defined on the <u>Centers for</u> <u>Disease Control Prevention (CDC) website</u>) may contact the court to reschedule their jury service.

If, at the time you are scheduled to appear for service, you are experiencing symptoms of COVID-19, please contact the court at the phone number provided on the jury summons to reschedule your service.

It is extremely important that the members of our community feel protected and safe when participating in the jury service process. 

Courtrooms have been set up to ensure that there is social distancing in each courtroom and that we know the number of people that will fit into each room.






Diagram of our two trial courtrooms
