 ) RELEASE SCHEDULE

It appearing to the Court that it is necessary to establish a security release schedule to provide for the release of persons arrested under ORS 133.310 and the Court of the 24<sup>th</sup> Judicial District having determined that the security release schedule herein establishes appropriate security amounts for various crimes;

And it further appearing that it is necessary to authorize certain persons to take security and release a person in custody under ORS 135.270;

NOW THEREFORE, IT IS HEREBY ORDERED that, effective immediately, unless security has been established by a magistrate in a different amount pursuant to warrant or order, either oral or written, the security release schedule is established in the following amounts:

Murder in the First Degree.....	NO BAIL
Murder in the Second Degree.....	NO BAIL

Attempt or Conspiracy to Commit Murder in the Second Degree.....	\$ 250,000

Probation violations for all other matters will be releasable and any necessary security will be commensurate with the crime of conviction.

The Security Release Schedule is to be imposed for each separate victim count and each separate incident the person is arrested upon.

When a person is returned to the custody of the Grant or Harney County Sheriffs' offices from the Oregon Department of Corrections or other local, state or federal correctional facility based upon an order or judgment of an appellate court for remand or reconsideration or a petition for post-conviction relief, security shall be the amount last set by a Circuit Court Judge in the underlying criminal action that gave rise to the remand or reconsideration or the petition for post-conviction relief.

The deputies, sergeants, administrative and command staff of the Corrections Division of the Grant or Harney County Sheriffs' offices are hereby designated as persons authorized to take security and release persons in custody under ORS 135.270.

The general conditions of release under ORS 135.250 and a condition prohibiting contact with any named alleged victim shall be imposed upon any person released under this order.

Nothing in this order shall be construed as having the effect of constraining the ability of the deputies, sergeants, administrative and command staff of the Corrections Division of the Grant or Harney County Sheriffs' offices to request that a magistrate make an individual determination


of the amount of security release for any person in custody otherwise eligible for release under this order.

Nothing in this order shall be construed as limiting release officers from determining if a person can be conditionally released under the general terms and conditions for Misdemeanors and Class C Felonies pursuant to established policies of Grant or Harney County.

All prior orders of this Court, regarding substantially the same subject matter of this order, are hereby rescinded and superseded by this order.

This order is continuing and shall remain in effect until rescinded or superseded by further order of this Court.
