** Monday holidays are marked with a double asterisk (**). Hearings that otherwise would be scheduled for a Monday that falls on a legal holiday will be heard on Monday in the following week. For example, a motion filed during the week of January 25, 2027, will be heard on February 22, 2027 (since February 15, 2027, is a holiday).

SLR 5.006(3): Motions, other than motions to postpone or continue and motions for summary judgment, will be heard on the next motion day that falls after twenty-one (21) days from the filing of the motion, unless a different hearing date is stipulated to by the parties and approved by the assigned judge.
