For example, a motion filed during the week of January 24, 2022, will be heard on February 28, 2022 (since February 21, 2022 is a holiday).

SLR 5.006(3): Motions, other than motions to postpone or continue and motions for summary judgment, will be heard on the next motion day that falls after twenty-one (21) days from the filing of the motion, unless a different hearing date is stipulated to by the parties and approved by the assigned judge.
