I. Certain legal issues will be resolved during the first part of Phase 3

The Court is informed that many parties assert that a significant number of exceptions raise legal issues that may be capable of resolution without the court's consideration or resolution of disputed issues of fact and are recommended as appropriate for resolution before proceeding to individual Partial Orders of Determination (PFOD) (collectively, "Phase 3, Part 1 Legal Issues"). The Court finds that the Adjudication process will be served by early resolution of such Phase 3, Part 1 Legal Issues. The Court accordingly intends to devote Part 1 of Phase 3 to resolving these Phase 3, Part 1 Legal Issues.

This case management order identifies Phase 3, Part 1 Legal Issues and sets a schedule and process for resolving them. The Court will issue subsequent case management order(s) addressing the procedures for Part 2 (and any subsequent parts) of Phase 3, which will involve the resolution of factual and legal issues that remain after the Phase 3, Part 1 Legal Issues are resolved. The Court anticipates that the remainder of Phase 3 will address the remaining issues in exceptions organized based on individual PFODs to which they apply, although to the extent individual PFODs involve common issues that remain unaddressed, they may be addressed together or otherwise consolidated for consideration and disposition by the Court.

For purposes of resolving Phase 3, Part 1 Legal Issues, the Court intends to resolve exceptions by groups, which will be organized based on the type of claim addressed in individual PFODs that are the subject of the exceptions.

The exceptor must certify in the first paragraph of the exceptor's motion that it has completed this requirement, and state the conferral parties' position on whether the topic is appropriate for Phase 3, Part 1 briefing. The Court will not entertain any motion that is not consistent with this requirement.

B. Certification

In the first paragraph of a motion regarding Phase 3, Part 1, the exceptor must certify that the issues raised in the motion raise legal issues that are not fact or claim-specific, and do not require resolution of disputed issues of fact.

C. Caption

In the caption of all documents, the filing party shall identify the issue(s) and/or issue-category(ies) addressed in the document. Parties may identify the issues by the number associated with that issue in the list in sub-sections V.A through V.C. above, as applicable.

D. Form for Motion

A motion filed by a party or group of parties during Phase 3, Part 1 Legal Issues briefing must satisfy all of the following requirements:

- 1. The motion must include in the same document a statement of the points and authorities supporting the motion;
- 2. A separate motion may be filed for each Phase 3, Part 1/Legal Issue for which a ruling is sought, however, parties are encouraged to file consolidated motions addressing multiple issues where possible;
- 3. At least one applicable exception per moving party and per issue must be identified in the motion. Parties must further identify each of their own exceptions to which the issue pertains, and list those exceptions in the motion. Motions to merely affirm findings in the ACFFOD will not be accepted by the Court.
- 4. For motions filed by counsel, motions containing more than 20 pages (exclusive of the caption) shall include a Table of Contents and Table of Authorities.

E. Form for Responses and Replies

A response or reply filed by a party or group of parties during Phase 3, Part 1 Legal

Issues briefing must satisfy all of the following requirements:

- 1. The first paragraph of any response must identify whether the respondent(s) is a claimant, has filed a request to be heard, or is the Oregon Water Resources Department.
- 2. Responses and replies may respond or reply to more than one motion, but each motion being responded to must be identified in the first paragraph of the response or reply. The parties are encouraged to file combined responses and replies where such an approach is likely to aid in efficiency of the Court's resolution of all motions.
 - For responses and replies filed by counsel, responses and replies containing more than 20 pages (exclusive of the caption) shall include a Table of Contents and Table of Authorities.

F. Citations


