INTRODUCTION

This proceeding is referred to as “The Klamath Adjudication.” This Case Management Order will be mailed to those listed on the current service list, dated April 17, 2015. This Case Management Order addresses the following:

1. Invitation to comment upon the Case Management Committee’s proposed Case Management Orders A, B, and C as follows:
 - A. Ordering that this case proceed in phases and specifying the processes for phase 1A regarding resolution of threshold issues and for phase II regarding undisputed exceptions;
 - B. Designating the list of issues or issue categories to be resolved in phase 1A; and
 - C. Designating processes for updating the court’s current service list and updates of related forms.
2. The court’s spreadsheet of claims, exceptions, and requests to be heard and a process to update and correct that document.
3. Notice that the court’s website for this case is being reformatted.
4. Notice that the electronic files for this case have been transferred to the Klamath County e-Court System.

1. CASE MANAGEMENT COMMITTEE PROPOSED ORDERS

The Case Management Committee delivered to the court the following documents:

- A. PROPOSED Case Management Order A which orders that this case proceed in phases and specifies the processes for phase I regarding resolution of threshold issues and phase II regarding undisputed exceptions.
- B. PROPOSED Case Management Order B that designates the list of issues or issue categories to be resolved in phase 1A.
- C. PROPOSED Case Management Order C that sets forth processes for updating the court's current service list and updates of related forms.

Parties to this case can submit comments regarding the proposed case management orders. Those comments must be filed with the court in writing by October 1, 2015, and must be served upon those listed in the current Service List. Replies only to comments submitted by other parties must be filed with the court in writing by October 15, 2015, and must be served upon those listed in the current Service List.

After considering any comments or objections, the Court may adopt the proposed orders in whole or in part or as modified as the Court determines in its discretion.

2. COURT'S SPREADSHEETS OF CLAIMS, EXCEPTIONS, AND REQUESTS TO BE HEARD AND A PROCESS TO UPDATE AND CORRECT THAT DOCUMENT

The court has prepared a spreadsheet of all 734 claims, exceptions, and requests to be heard which can be found on the court's web site at <http://courts.oregon.gov/Klamath/pages/water.aspx>.

A document entitled *Process for Updating the Court's Spreadsheet*, which can also be found on the court's website, sets forth a process for updating and correcting the spreadsheet.

Over time, the court may update or create other spreadsheets, and will provide notice when it does so. The date that the spreadsheet was last updated is located in the header of the court's spreadsheet. The current spreadsheet – dated July 1, 2015 – will be changed when the spreadsheet is updated to enable users to verify they are using the most current version.


3. COURT'S WEBSITE FOR THIS CASE BEING REFORMATTED

The court's Adjudication website, <http://courts.oregon.gov/Klamath/pages/water.aspx>, will be reformatted by October 1, 2015, to better organize documents related to this case. Court documents will be added as they become available.

4. ELECTRONIC FILES FOR THIS CASE TRANSFERRED TO KLAMATH COUNTY E-COURT SYSTEM

Effective July 20, 2015, the Klamath County Circuit Court is e-filing through the File and Serve system (<https://oregon.tylerhost.net/>). Beginning on that date, all Klamath Adjudication electronic documents should be e-filed in Klamath County instead of Jackson County. The case file register has been moved to Klamath County from Jackson County, so all Klamath Adjudication e-files are now available through the Klamath County e-Court system. No further changes to the e-filing process have been made. If you have any questions, please contact the Klamath County Circuit Court's Trial Court Administrator or Civil Operations Supervisor.
