INTRODUCTION

This proceeding is referred to as “The Klamath Adjudication.” This Case Management Order will be mailed to those listed on the current service list provided by the court on October 17, 2014. This Case Management Order addresses the following:

1. The Court’s Order finding good cause to extend the time to set hearings on exceptions under ORS 539.150(3).
2. The Court’s Order setting over the deadline for filing requests to be heard to January 16, 2015 at 5:00 pm.
3. The Court’s Order setting over the Case Management Conference to March 18-19, 2015 starting at 9:00 am each day
4. The Court’s Order setting over proceedings on motions until after the Case Management Conference
5. Information about access to exceptions

1. ORDER UNDER ORS 539.150(3) FINDING GOOD CAUSE TO EXTEND THE TIME TO SET HEARINGS ON EXCEPTIONS

This matter having come before the court upon its own motion, the court finds that the complexity and number of exceptions filed to be good cause to extend the time to set hearings on exceptions beyond the initial hearing;

IT IS HEREBY ORDERED that the hearings on exceptions will not be set until after the

Case Management Conference has been conducted on March 18 and 19, 2015.

2. ORDER SETTING OVER DEADLINE FOR FILING REQUESTS TO BE HEARD

This matter having come before the court upon its own motion at the initial hearing on October 17, 2014, the court having entered this order orally at that hearing,

IT IS HEREBY ORDERED that the deadline for filing Requests to be Heard is January 16, 2015 at 5:00 pm., NOT December 3rd, 2014 as set forth in Case Management Order #7.

3. ORDER SETTING OVER CASE MANAGEMENT CONFERENCE

This matter having come before the court upon its own motion at the initial hearing on October 17, 2014, the court having entered this order orally at that hearing,

IT IS HEREBY ORDERED that the Case Management Conference will be conducted March 18-19, 2015 starting at 9:00 am each day, NOT February 4-5, 2015 as set forth in Case Management Order #7.

4. ORDER SETTING OVER PROCEEDINGS ON MOTIONS UNTIL CASE MANAGEMENT CONFERENCE

The court has received a motion to amend Claim 13 and a motion to amend Claim 133 and anticipates that other motions may be filed,

IT IS HEREBY ORDERED that unless the court orders otherwise, proceedings on all motions will be set after the Case Management Conference has been conducted on March 18-19, 2015. This order does not apply to Petitions for Stay.

5. INFORMATION ABOUT ACCESS TO EXCEPTIONS AND OTHER RELATED DOCUMENTS FILED IN THIS CASE.


