



## **Multnomah County Circuit Court COVID-19 Update for March 21, 2020**

Out of concern for public health and preventing the spread of COVID-19, the Multnomah County Circuit Court is moving to further restricted operations to greatly reduce the number of people coming into court facilities. The court is following the Chief Justice Order issued March 16, 2020, limiting the court to statutorily required proceedings through March 27<sup>th</sup>. This order may be extended by the Chief Justice beyond March 27<sup>th</sup>, if determined necessary.

**Most public service counters and phone lines have been shut down. See below for department specific information and email addresses.**

### **JURY**

**If you are a Juror who received a summons for any of the following days: Monday March 23rd, Tuesday March 24th, Wednesday March 25th, or Thursday March 26th, your appearance is not needed. Please do not come to the courthouse.**

- If you are a Grand Juror please report as instructed.
- Most matters needing jurors have been rescheduled.
- Jurors should call the number on their juror summons after 5:00pm the day before they are summoned to report to find out if they need to appear for service.

### **CIVIL**

- All civil jury trials are being postponed to be held after April 30<sup>th</sup>
- Civil Ex Parte will only be held in the morning, from 10:30am-11am, or until finished. Presiding Court phone lines will be open until noon. Please, only come to ex parte if delay would violate a statutory or constitutional right, jeopardize public health or safety, or would result in imminent irreparable harm.
- Rule 7 Change - Civil cases with pending deadlines pursuant to UTCR 7.020(2) and/or (3) before April 30<sup>th</sup>, 2020, shall receive an automatic 60-day extension from the due date.

## **LANDLORD TENANT**

- All Landlord Tenant hearings and trials through 3/27/20 will be rescheduled to be held after March 30<sup>th</sup>.

## **SMALL CLAIMS**

- Small claims hearings and trials through 4/13/20 will be rescheduled to be held after April 30<sup>th</sup>.

## **CRIMINAL**

- The court will continue to hold in-custody arraignments, in-custody probation violation hearings, in-custody pleas, in-custody probable cause hearings, in-custody release hearings, and in-custody substitution hearings.
- Trial assignment and short matters dockets (Presiding and CPC) will be conducted via phone for the purposes of setting new call and trial dates.
- Justice Center public service counter remains open.

## **FAMILY LAW**

- The court will conduct in-custody violation of restraining orders (VRO) and in-custody support enforcement (SED) matters.
- Restraining order applications and immediate danger motions will be accepted at the Justice Center before noon each day.
- Contested restraining order hearings will be scheduled and parties will be sent notice with the date, time and location.
- Immediate danger motions will be heard at 1:15 each day at the Justice Center. If a hearing is requested, parties will be notified and sent notice with the date, time and location of the hearing. Specially assigned cases will be scheduled through the assigned judge.
- All cases which are on the Trial Assignment docket between today and April 30 will be re-set and notices will be sent. There will be no Trial Assignment docket.

- All other matters currently set on a judge's calendar between today and April 30 will be re-set and notices will be sent.
- Civil commitment hearings will be held by phone, rather than occurring in hospitals.

## **JUVENILE**

The only matters that will be heard at the juvenile court are the following:

- Protective custody orders (presented to the on-call judge electronically)
- Shelter hearings
- Delinquency in-custody initial appearances
  - In-custody probation violations
  - 10-day detention reviews and 28/56 day detention duration hearings

All other juvenile matters, including but not limited to dependency review and permanency hearings, will be re-set to a date after April 30. Judicial officers' staff will notify parties of new dates.

## **PROBATE**

- Temporary guardianships and temporary conservatorships will be heard if scheduled through the Probate Department.
- All trials and hearings through April 30<sup>th</sup> are being rescheduled.
- The Probate Department is closed for in-person matters.

## **TRAFFIC**

- The Traffic Department is closed for in-person matters. Traffic trials through 4/13/20 will be rescheduled to be held after April 30<sup>th</sup>.
- Traffic first appearances will not be able to occur in person. Defendants will not be penalized for failing to appear in person or otherwise failing to respond to citations during this period; citations appearance deadlines will be extended to beyond April 30<sup>th</sup>.

- Ceased imposing penalties for failing to appear or pay for traffic citations or failing to comply with court-ordered classes during this period.

## **PARKING**

- The Parking Department is closed for in-person matters.
