WHAT YOU MUST BRING: Marriage License, Certificate & at least 2 witnesses (18 yrs. old or older)

\*\*FEES: ORS 106.120(4)(a) requires the payment of a \$110.00 fee to the Multnomah County Circuit Court for all marriages performed at the Courthouse. This fee must be paid prior to the wedding. Please ask the judge's staff where to pay this fee when scheduling the wedding. In addition to the \$110.00 fee, there is a \$100 Judge fee for weddings outside regular court hours (5:00 p.m. or after) or outside chambers. 6/21/19
