We did all mediations together in the offices of NW Mediation, with 2 mediators for every divorcing couple, one attorney and one therapist. I did this from 1986 until 1994 when I moved to Indiana. I also started mediating without a partner in 1990.

I took an additional 40 hours of training in Indiana to be registered with the Indiana Supreme Court as a mediator (I have retired from the bar in Indiana and Washington)
