## BENCH PROBATION INFORMATION

You have been placed on probation to the court. This information is being provided to assist you in achieving a successful compliance with your bench probation.

- Review the conditions of your probation as set forth in the judgment document you received in court. If you need another copy of the judgment, you may purchase a copy in the Trial Court office, room 135. In some cases, they are on the back of a judgment form.
- The financial obligations are due immediately after court. Proceed directly from court to room 135 on the first floor to make your payment. See the box at the bottom of this page for other payment options. If you are unable to make full payment today, you are required to complete a Payment Plan Agreement and comply with payment arrangements. The court may add a \$25.00 fee to each case included in a payment plan that will continue for more than 12 full months. If you do not pay as ordered or stop paying on your payment plan your case will be sent to collections. Cases sent to collections incur substantial additional collection assessments.
- If "bail" was posted by you, or by another person on your behalf, the bail will be subject to a 15% fee (\$750 maximum) and the remainder after the fee will be used to pay any outstanding balances you have with this court or any other circuit court in the state.
- If you are ordered to complete any special conditions, evaluations and treatment, <u>you</u> are responsible to provide proof of completion to the court within the timeframe ordered by the court. If you do not, you will be ordered into court for probation violation proceedings. If your probation is revoked, you could face up to the statutory maximum for the class of crime for which you were convicted. This can involve fines, fees, jail time, work crew and other consequences.
- You must keep the court informed of your current mailing and residential address. This ensures you will receive any information forwarded to you from the court. Failure to do so may also result in a probation violation and could result in a warrant for your arrest if you fail to show up at a hearing when notice to that hearing was sent to an address that you have not kept up to date.
- If you must undergo an evaluation and/or participate in treatment or a program, it is important to start that right away. Do not wait. A list of resources for evaluations, treatment, or other programs is available in the Trial Court Office, room 135 or at our website. Go to the Program & Services tab then Criminal section, there you will find a current list of evaluation, treatment, and other program services to help you successfully complete your Bench Probation.
