3. I believe this conduct violated the victim's rights granted by Article I, sections 42(1)(a) to (g) and 43, of the Oregon Constitution. Specifically the right to:

- ☐ be present at and upon specific request, to be informed in advance of any critical stage of the proceedings held in open court when the defendant/youth is present, and to be heard at the pretrial release hearing/detention hearing and the sentencing/disposition
- ☐ obtain information about the conviction/adjudication, sentence/disposition, imprisonment, criminal history, and future release from physical custody of the defendant/youth upon request
- ☐ refuse an interview, deposition, or other discovery request by the defendant/youth or other person acting on behalf of the defendant/youth
- ☐ receive prompt restitution from the convicted defendant/adjudicated youth who caused the victim loss or injury
- ☐ have a copy of a transcript of any court proceeding held in open court, if one is otherwise prepared
- ☐ be consulted regarding plea negotiations involving any violent felony upon request
- ☐ be informed of the above-listed rights as soon as practicable
- ☐ be reasonably protected from the defendant/youth throughout the criminal justice process
- ☐ have decisions by the court regarding the pretrial release of the defendant/youth based upon the principle of reasonable protection of the victim and the public, as well as the likelihood that the defendant will appear for trial/adjudication

4. I ask the court to order:

I ask that the court grant an appropriate remedy or schedule a hearing to determine whether the victim's rights were violated

I hereby declare that the above statements are true to the best of my knowledge and belief. I understand they are made for use as evidence in court and I am subject to penalty for perjury.
