The designation of Joint or Sole Custody is set forth in the Judgment or Order to which this parenting plan is attached and which has been signed by a Judge.

1. Parenting Time Schedule

The children shall be with Parent B on the following schedule. They shall be with Parent A at all other times unless otherwise specified in Sections 1.1 and 1.2. If a child turns 3 years old and there is no schedule in 1.1(b), then the schedule in 1.1(a) will continue.

☐ If there are children who would have different parenting time schedules because they are in different age groups, parenting time for all the children shall be based on the schedule for the oldest child that is present for the parenting time, unless a child is younger than 36 months. In that case, the schedules for "Children ages birth to 12 months" and "Children ages 1 year and older who have not turned 3 years old" shall apply to those children as set forth in Sections 1.1 and 1.2.

11. Child Safety Rules

- ☐ There shall be no firearms in the home or in the children's presence during parenting time.
- ☐ The children shall not be physically disciplined.
- ☐ Medications prescribed by a licensed physician shall not be withheld from the children and both parents shall ensure that medications are administered as prescribed. The children must have the medication when parenting time starts and it must be returned with the children when parenting time ends.
- ☐ The following person(s) shall not be present during parenting time:

- ☐ Alcohol shall not be consumed beginning 12 hours before the children arrive through the time they are returned to the other parent.
- ☐ Intoxicating liquor, marijuana, or other controlled substance (drugs) as defined in ORS 813.010 shall not be consumed beginning 12 hours before the children arrive through the time they are returned to the other parent.

13. Information Sharing (ORS 107.154 and ORS 107.164)

Unless otherwise ordered by the court:

- Each parent shall have equal access to important information about the children including, but not limited to, the children's current mailing address, street address, and telephone number.
- Each parent shall immediately notify the other parent about any emergency circumstances or substantial changes in the health of the children.
- If either parent takes the children from that parent's usual residence for 24 hours or more, that parent shall notify the other parent of any emergency contact phone number and where the children will be staying.

Unless otherwise ordered by the court, both parents always have the right:

- To inspect and receive school records and to consult with school staff concerning the children's welfare and education.
- To inspect and receive governmental agency and law enforcement records concerning the children.
- To consult with any person who may provide care or treatment for the children and to inspect and receive the children's medical, dental, and psychological records.
- To authorize emergency medical, dental, psychological, psychiatric, or other healthcare for the children.

14. Future Move of a Parent

Unless otherwise ordered, if either parent wants to move more than 60 miles further away from the other parent, written notice of the move shall be provided to the Court and the other parent at least 45 days before moving. This requirement applies to both parents regardless of who has legal custody of the children. If the move will impact the other parent's time with the children, a change to the parenting time schedule shall be made as described in Section 15 below.

15. Changes to the Parenting Plan

Changes to the parenting plan may be made if both parents agree. The changes will not be enforceable unless the changes are part of a Judgment or an Order that has been signed by a Judge. A parent may also ask the Court to make changes to the parenting plan by filing a modification, even if the other parent doesn't agree, as long as the changes are in the best interests of the children.

16. Enforcement

This plan is enforceable by the Court when it is a part of a Judgment or an Order that has been signed by a Judge. If one parent does not follow the rules in this plan, the other parent is not excused from following the rules.

17. Mediation
