

# Converting Separation Judgment to Dissolution Judgment Forms and Instructions

This packet is for parties who have obtained a Judgment of Separation within the last two years.

## **STEP 1**

Fill out the following forms:

- *Petitioner's/Respondent's Ex Parte Motion for Order to Show Cause Regarding Conversion of Judgment and Declaration* (**MOTION**)
- *Record of Dissolution of Marriage/Registered Domestic Partnership*

The case heading (names and case number) on each form will be the same as it was on the Separation Judgment. Make two copies of the **MOTION**.

## **STEP 2 (CHOOSE OPTION A, B OR C)**

### **A. IF YOUR SPOUSE/PARTNER HAS NOT CONSENTED TO THE CONVERSION:**

Also fill out the following form:

- *Order to Show Cause Regarding Conversion of Judgment* (**ORDER**)

Make copies the **MOTION** and **ORDER**.

File the **MOTION**, **ORDER**, and **Record of Dissolution of Marriage/Registered Domestic Partnership**

### **B. IF YOUR SPOUSE/PARTNER CONSENTED TO THE CONVERSION BEFORE FILING YOUR PAPERS:**

Have your spouse/partner fill out and sign the following form:

- *Consent to Conversion and Waiver of Right to Hearing* (**CONSENT**)

Fill out the following form:

- *Supplemental Judgment of Dissolution Converted from Judgment of Separation* (**JUDGMENT**)

Make copies of the **JUDGMENT**.

Mail the **JUDGMENT** copy and the *Notice of Proposed Judgment* (**NOTICE**) to the other party

Wait 7 days and file the **MOTION**, **CONSENT**, **Record of Dissolution of Marriage/Registered Domestic Partnership**, and **JUDGMENT**

### **C. IF YOUR SPOUSE/PARTNER CONSENTS TO THE CONVERSION AFTER BEING SERVED WITH THE PAPERS IN STEP #3:**

After being served (see Step #3 below), your spouse/partner may **CONSENT** to your request. The law allows your spouse/partner to file a written **CONSENT** at any time before the hearing.

Have your spouse/partner fill out and sign the following form:

- *Consent to Conversion and Waiver of Right to Hearing* (**CONSENT**).

Fill out the following form:

- *Supplemental Judgment of Dissolution Converted from Judgment of Separation* (**JUDGMENT**)

Make copies of the **JUDGMENT**.

Mail the **JUDGMENT** copy and the *Notice of Proposed Judgment* (**NOTICE**) to the other party

Wait 7 days from the date of mailing and then file the **JUDGMENT**

### **STEP 3**

**THE INSTRUCTIONS BELOW ARE TO BE FOLLOWED IF YOUR SPOUSE/PARTNER HAS NOT CONSENTED TO THE CONVERSION BEFORE YOU FILE THE PAPERS IN STEPS #1 and #2(A).**

Once the judge signs the **ORDER**, obtain a court copy from the copy center for a fee or conform your own order by placing /s/ on the judges' signature line and print the judge's name who signed your order.

Serve the other party with copies of the **MOTION** and **ORDER**. You may have the other party served through the sheriff's office, a private process server, or someone over the age of 18. You cannot serve documents to the other party.

Have your server complete the following form:

- *Certificate of Service* (**SERVICE**)

File the completed **SERVICE** form

### **STEP 4**

After 30 days has passed from the date of service, you may file a default. The judgment may also be filed at this time.

File the following forms:

- *Exparte Motion for Order of Default and Declaration*
- *Order of Default*
- *Supplemental Judgment of Dissolution Converted from Judgment of Separation* (**JUDGMENT**)

The court will send a Notice of Entry of Judgment after your judgment is signed by the judge. This process may take a week to 10 days. After receiving your notice, you may purchase a copy of the signed judgment by contacting the Copy Center at (541) 812-8770.

Points and Authorities

ORS 107.465 allows the Court to convert a judgment of separation to a judgment of dissolution within two years after the entry of the judgment of separation.
