The following are your rights under the Indian Child Welfare Act:

1. Rights to an attorney or appointed counsel and, if the court determines you cannot afford counsel, you have the right to court-appointed counsel (if you are the child's parent or Indian custodian).
2. Right to request that the child-custody proceeding be transferred to Tribal court,
3. Right to object to a transfer to Tribal court,
4. Right to request additional time to prepare for the child custody proceeding as provided in § 23.112. Up to 20 additional days from the date upon which notice was received can be granted to prepare for participation in the proceeding.
5. Right to intervene (if the parent or Indian custodian is not already a party in a child custody proceedings).

If a guardian is appointed for the minor, the rights of the minor's parents and Indian custodian (if any) may be affected, including rights pertaining to legal and physical custody of the minor.

All parties receiving this notice must keep confidential the information contained in the notice and this notice should not be handled by anyone not needing the information herein to exercise rights under ICWA.

If you wish to receive copies of future filings in this case but do not want to object at this time, you may use the included Request for Notice form (**Form 6**, included in the attached documents). There is a \$281 filing fee, which can be waived or deferred with the Court's Fee Waiver or Deferral packet. If you choose to do this, file the request for notice with the Court and mail a photocopy to the petitioners.

Unless you take these steps, you will receive no further copies of the filings in the case.
