

## PACKET C: ARRESTED AND CONVICTED IN COURT OF CHARGE(S)

Use the case number associated with the court for this charge. There is a \$281.00 filing fee for this type of set aside. The fee is non-refundable. If your Motion for Order is denied, the funds will not be returned to you.

### OVERVIEW:

Things you will need to complete this process:

- ✓ Determine your eligibility. Carefully read ORS 137.225.  
*NOTE: The court cannot advise you of your eligibility.*
- ✓ Prepare your forms and get a complete set of your fingerprints.
- ✓ Deliver copies of your forms and fingerprint card to the District Attorney's Office.
- ✓ Deliver and file the Original forms with the Marion County Circuit Court.
- ✓ Pay the court filing fee (\$281).

### ELIGIBILITY:

You will need to determine if your arrest is eligible to be set aside. For eligibility refer to Oregon Revised Statutes ORS 137.225.

### PRIOR TO FILING:

#### Fingerprints:

You only need one fingerprint card regardless of the number of cases you are filing at the time.

Fingerprint cards may be obtained Monday through Friday from 8 a.m. to 4:30 p.m. at the Oregon State Police Bureau of Criminal Identification located at 3565 Trelstad Avenue SE, Salem, Oregon. There is a fee for this service. Call (503) 378-3070 to verify the schedule and fee amount.

The fingerprint card should contain the notation "Motion for Setting Aside Arrest Record."

#### Forms:

You must submit the original Motion, Affidavit and Order to the Marion County Circuit Court, Accounting Department – 1<sup>st</sup> Floor, 100 High Street NE, Salem, Oregon. You must prepare separate documents for each arrest.

Sign all documents where your signature is required. **You must sign the affidavit in the presence of a Notary Public or a Court Clerk.**

*NOTE: You can find case information via the public kiosks located at the Marion County Circuit Court, 100 High ST NE, Salem, OR 97301.*

**Copies:**

Make two copies of the forms. One to serve to the District Attorney's Office. One for your records.

**Service on the District Attorney:**

A copy of the Motion, Affidavit and Order along with the original fingerprint card must be served to the District Attorney's Office located at 555 Court Street, Courthouse Square – 3<sup>rd</sup> Floor, Salem, Oregon. You must also include a certified check or money order for \$80.00 made out to "Oregon State Police."

## WHAT HAPPENS NOW?

The District Attorney's office will forward the fingerprint card to the State Identification Bureau to confirm your identity. It will also be used to determine if there have been any other incidents that would cause them to want to object to your request.

The District Attorney's office will then file an Answer to your Motion and send a copy to you or your attorney. The Court will then decide, based on the documents filed, whether the Order is granted or denied. A copy of the Order will be provided to you or your attorney. If the Order is granted, copies will be sent to the agencies that have your arrest record(s). (The court has no control over the agency timeline to get the arrest removed.) The Order will include the Court file to be sealed.
