THE COURT FINDS:

1. Defendant lacks fitness to proceed, as defined by ORS 161.360(2).
2. In consideration of the primary and secondary release criteria (ORS 135.230), the least restrictive option appropriate for the defendant, and the needs of the defendant and the interests of justice, the appropriate action for this defendant is community restoration. However, the services and treatment necessary to allow Defendant to gain fitness to proceed are not present and available in the community.
3. The following services and treatment are necessary to allow Defendant to gain fitness to proceed through community restoration:

THE COURT ORDERS (*check all that apply*):

1. Criminal proceedings against Defendant in this case are suspended

3. The _____ County CMHP Director, or designee, is to coordinate and consult with resources, facilities, programs, providers, and agencies about appropriate actions and review available treatment and services to allow Defendant to participate in community restoration.
4. The charges will be dismissed in a separate judgment.

NOTICE OF FIREARMS PROHIBITION

The court has found that Defendant is not currently able to move forward with their criminal case due to a qualifying mental disorder. As a result, federal law prohibits Defendant from having or buying firearms (guns or ammunition). The Oregon Judicial Department reports the prohibition on Defendant from buying firearms and ammunition to the Oregon State Police.
