# **About Zoom Mediations**

- Zoom allows you to participate in a session virtually, which means you are able to:
  - view and hear the mediator and the other person over your desktop or laptop computer, tablet or smart phone
  - view documents shared by the mediator or by one of you
  - choose options to match your comfort level (opt out of video, chat privately with the mediator, etc.)
  - have one-on-one time with the mediator (matched by equal time between the mediator and the other person)

## **Protocols for Parting Waters Zoom Mediations**

- We recommend logging into your session a few minutes before it starts to allow for any necessary troubleshooting.
- Because mediation is confidential, we ask that you insure that there is no one else in the room or in earshot of the session.
- If you lose internet connection during the meeting, log back in and the mediator will admit you back into the room.

# To Join by Computer

#### Step 1:

Download plug-in for Zoom software: https://zoom.us/download#client\_4meeting

(Although not necessary, this will prevent you from having to download each time you join a session)



#### STEP 2:

A few minutes before the meeting, click the link to Zoom meeting shared in your appointment confirmation email. It will look similar to the link below:

**STEP 3:** Select "Open Zoom Launcher" (message appears if you have not downloaded according to step 1)



#### STEP 4: Connect to Audio

Join through your speakers and microphone. "Test" audio before connecting.



**Step 5:** Wait for host (mediator) to join and then the session will begin.
