The State Family Law Advisory Committee (SFLAC) is currently a 16-member panel of judges, trial court administrators, mediators and evaluators, attorneys, family court service providers, and representatives from various state agencies. The Chief Justice of the Oregon Supreme Court appoints SFLAC members to advise the State Court Administrator on family law issues in the courts (ORS 3.436). The SFLAC also plans and implements an annual statewide conference on family law issues in Oregon to the extent that funds are available. It meets quarterly and has several subcommittees that research and provide technical assistance on specific issues of concern in family law or pertaining to family courts.

What Makes an "Expert" an Expert? Identifying Real Experts in Custody Cases with Resist Refuse and Child Abuse Allegations

The Plenary analyzes expert testimony in custody cases with contact resistance/refusal where parents allege alienation rebutting child abuse (CA) or sexual abuse (CSA) allegations against them. It presents questions to help judges qualify expert witnesses as alienation or CA/CSA experts. It scientifically refutes claims that false CA/CSA allegations are common in custody cases. It identifies case-specific evidence needed to support or refute either allegation. It presents cross-examination questions that help attorneys undermine expert opinions and recommendations not supported by case-specific evidence.

Presenter Bios

Hon. Sean Armstrong has served on the Marion County bench since 2016. As part of his judicial duties, Judge Armstrong created and runs a docket comprised entirely of self-represented litigants with custody and parenting time cases. He encourages collaborative resolution of cases through court-sponsored mediation and judicial settlement conferences when appropriate, and also educates litigants on the value of the Informal Domestic Relations Trial Rules as a mechanism for ensuring that self-represented litigants have access to the court's decision-making process in a way that provides them with a meaningful opportunity to be heard. Prior to his appointment, he was an associate and then shareholder at Garrett Hemann Robertson PC in Salem, focusing his practice on family law matters from 2004 until he was appointed to the bench. He has volunteered his time by serving as the Marion County Bar Association President, and now serves on the State Family Law Advisory Committee, as well as the SFLAC Parental Involvement and Outreach Subcommittee. He also serves as a member of the Marion County Domestic Violence Counsel, and as Chair of the Marion County Family Law Advisory Committee. Judge Armstrong has co-authored several state and local family law forms, written and revised Marion County Supplemental Local Rules on family law topics for adoption, and frequently presents CLE material to attorneys, judges, mediators, and law students, addressing all aspects of substantive family law issues, as well as family law trial and settlement practice.

Dr. Wendy Bourg began her work on helping children and parents manage high conflict divorce in graduate school when she helped run a clinic for children of divorce. She conducted her master's thesis and dissertation research on children's behavioral and physiological responses to adult anger and domestic violence. In her current practice she conducts custody and parenting studies and maintains a clinical schedule focused on parent coordination and family therapy in Resist Refuse dynamics. Dr. Bourg's practice emphasizes the complex underpinnings of family conflict and seeks multiple points of intervention that can move the family system to a more peaceful place. Her focus is on problem-solving in the context of a strong respect for the importance of healthy attachment relationships to both child and adult functioning. While the work is very challenging, both intellectually and emotionally, Dr. Bourg embraces the challenge of helping these families travel through this period of crisis to a better place.

Maleea Briggs is a Child Protective Services (CPS) Supervisor at the Midtown branch in Portland, Oregon, with 15 years of experience in the social work field, spanning various areas of practice. For the past eight years, she has specialized in CPS, where she worked closely with families navigating family law issues and challenging circumstances, ensuring children's safety while supporting parents in accessing resources and services. Her role has involved working with families in crisis, providing them with the necessary support while their children were in care, and helping them work toward reunification. She holds a bachelor's degree in social work and a master's degree in Nonprofit Leadership, as well as two certificates in Child and Family Development, which have equipped her with a strong foundation in both direct social work practice and leadership in nonprofit settings. Her expertise is centered on advocating for the well-being of children and supporting families as they navigate the complex services and systems within the Oregon Department of Human Services (ODHS). She believes in a collaborative and empathetic approach to social work, particularly during the CPS stage, where her philosophy is to listen first and judge later. This approach helps her build trust with families, allowing her to understand their unique circumstances and collaborate effectively in finding solutions. She views the process as fitting the right puzzle pieces together, ensuring families receive the necessary support while maintaining the safety and best interests of the children.

Additionally, she works closely with legal partners to ensure that decisions made throughout the CPS process reflect what is truly best for the child, balancing legal requirements with compassionate, family-centered care.

Emily Brown-Sitnick (she/her/ella) is the Regional Director of the Portland Regional Office of Legal Aid Services of Oregon. Emily attended Knox College in Galesburg, IL, and the University of St. Thomas School of Law in Minneapolis, MN. Emily is bilingual in English and Spanish. She started her legal career as a paraprofessional within Legal Aid before heading to law school. She has a background in administrative law, civil rights, immigration and family law while specializing in services for survivors of domestic and sexual violence, stalking and trafficking. Emily sits on the DV subcommittee of the SFLAC as well as the 2025 Multnomah County Fatality Review. She is the immediate past co-chair of the Oregon Hispanic Bar Association and is on the board of Oregon Women Lawyers.

Hon. Sara Collins attended University of Oregon to obtain her bachelor's degree in political science. After college, Sara spent a year in Costa Rica teaching English to elementary-aged children. Upon her return to the United States, Sara attended the University of Oregon School of Law graduating in 2001. Sara moved on to complete a judicial clerkship in Alaska where she discovered her true passion for trial work. In 2004, Sara returned home to Oregon, where she dedicated 11 years as a public defender, and worked as an Assistant Attorney General for the Oregon Department of Justice Child Advocacy Section. In 2016, She transitioned to private practice, and in 2018 became a founding partner of Collins Rowan, LLP where she represented clients in juvenile, family law, and criminal cases. She worked at Collins Rowan, LLP until her appointment to the Jackson County Circuit Court in June of 2023. Continuing her commitment to serving her community, Sara has served on the board of directors of La Clinica for the past eight years. Sara also serves on the board of directors for Lane County based nonprofit, Oregon Mind Body Institute (OMBI). Most recently, Sara joined the board of directors for the Rogue Valley Family YMCA. Outside of the courtroom, Sara enjoys reading, running, skiing, and spending time traveling with her husband and children.

Christie Combs is a Business Process Analyst with the Enterprise Technology Services Division. She is currently responsible for creating new or updated statewide business processes for the Oregon Judicial Department, working on legislatively driven projects, and assisting court staff with research and development. Prior to Christie's work at ETSD, she was a supervisor with the Deschutes County Circuit Court for 18 years. In this role she enjoyed working in the areas of civil law, probate law, criminal law, juvenile dependency and delinquency, mental health, and of course family law. Christie enjoyed being part of a dynamic team and the opportunity to continue learning new things in an environment of ever-changing laws and policies.
