The meeting was called to order at 1:02 PM.

WELCOME AND INTRODUCTIONS

Justice Nelson welcomed everyone. Check in with Council members (what are you looking forward to: What is going well, and it would be even better if?)

Congratulations to Sophorn Cheang on new position as the Director of Business Oregon. Sophorn shared that Shannon Singleton will be the new director of Diversity, Equity and Inclusion for the Governor's Office.

Justice Nelson acknowledged Cathryn Bowie for her work in making the law library accessible to incarcerated individuals. Valerie shared article highlighting Cathryn's work.

MINUTES

John Haroldson moved to approve the minutes from the November 2020 meeting. Mariann Hyland seconded the motion.

PROPOSAL FOR OJD TO COLLECT RACE, ETHNICITY, AND GENDER DEMOGRAPHIC DATA

Presenters: Valerie Colas and Jessica Roeser

Materials: Proposal from Data Analysis Subcommittee

PRESENTATION:

- Justice Adrienne Nelson provided background on the need to collect race, ethnicity, and gender data. Also shared that there is a policy option package (POP) in the legislature to get funding for OJD to be able to collect this demographic information. Justice Nelson also acknowledged Jeff Hall for his work on this.
- Jessica Roeser shared the challenges that OJD has with its current ability to collect race, ethnicity, and gender data. The data that we have in our system is mostly observed data that comes from law enforcement agencies. Another challenge with Odyssey is that we do not have configurable options for race and ethnicity, and the options that are available are incomplete and ambiguous, so we have a lot of underrepresentation for white Hispanic and Native American individuals. The other challenge that complicates things even further is that violations from ecitation system is not correctly mapped, so we have a lot of over-representation for white non-Hispanic. So, if an officer writes Hispanic on the ticket there is not programing to accommodate to update Odyssey to white Hispanic.
 - We do not know about the quality of the data we do not have a Business process or statewide effort to collect race and ethnicity data to enter this information or how to do so when there is ambiguity and it is not possible with Odyssey at this time.
 - We are having meetings with Tyler to see if we can get configurable race and ethnicity and gender options. And other Tyler customers are asking for this as well –they want it to be configurable to have their own drop-down options.
 - We have been collecting self-reported race and ethnicity data from Department of Correction (DOC) – we have an integration with them -- that is in our data warehouse. The decision that we need to make, if we want to start collecting this data from criminal cases, is how to use this (CJC also uses this data because it is a good source of information).
 - We would need to make the decision about whether to collect self-reported data and how to do so what are the business processes for this.

• The Data Analysis subcommittee would be the one that helps with figuring out how to do this and provide the best practices. This would probably be a 5-month timeline to get this done. We would also include stakeholders in this process and find out other collection efforts that are taking place within OJD. For instance, specialty courts are also collecting race and ethnicity data.

EQUITY LENS

PRESENTATION:

- We have provided the draft of the document that Erin Pettigrew wrote. We have gotten input after we did a presentation from Presiding Judges in January. And we also presented in webinars in February. Overwhelmingly, we got feedback that we should adopt an equity lens and that it would be helpful for our work at OJD from those who participated in the webinars and from the presiding judges.
- OSCCIF will be voting by email on this.
- Other states may want to use our Equity lens for their own hoping to get as much feedback from Council members before this is finalized.

DISCUSSION

- John Haroldson noted that it is so much easier to address issues on equity when we have an audience that is receptive. Further noted that in discussing these issues and seeking feedback must be mindful that there are folks that have a strong opposition to applying an equity lens. And that we need to be mindful there may be challenges that we face that may dilute or derail the process. For instance, the concept of diversity of thought being offered as an interesting concept but it shifts the discussion from people to the process.
- Jim Belshe shared that the trial court administrators did receive the equity lens and that it was time for us to start on this effort even if there are some who are not ready yet.

OJD Strategic Campaign Initiatives 2.1 and 4.1

Initiative 2.1 - We will launch and participate in collaborative initiatives to better serve self-represented litigants throughout the state.

(Team: Valerie Colas and Nanci Thaemert – Co-Leads; Erin Pettigrew – Executive Lead; Judge Jenefer Grant and Judge Maureen McKnight – Judge Sponsors; Tina Qualls – Trial Court Administrator Sponsor)

• This initiative is still moving forward. Ongoing projects are the self-represented litigant legal portal, legislative concepts, and POP for facilitators, developing Title-IV program to get federal reimbursements for child support cases. Judge Maureen McKnight is helping tremendously with this initiative.

Initiative 4.1 – We will provide judges and staff with ongoing education and training in the areas of diversity, equity, and inclusion. (There is another similarly related initiative to provide training to court security personnel – Initiative 4.2).

- We are continuing with the webinar series called Conversations on COVID-19, Protests, and Moving Forward.
- We have held a Black History webinar and Equity Discussions webinar. At our upcoming webinar, Kim Rockeman will be helping with introducing Blake Dye, who will be our new Equity and Engagement HR manager working of the equity, diversity, and inclusion efforts for OJD.
- We have also invited judges and staff to engage in the ABA-Wide 21-Day Racial Habit-Building Challenge. Valerie will forward the link to members.
- We are moving forward with our pilot project with Massachusetts court to provide their Signature Counter Experience training. They will be providing the training virtually in June and July for Marion County Circuit Court.
- We participated in the first Oregon Legal Diversity Fair in March. We also held an informational session on judicial clerkships for law students with our appellate and tax court judges.
- In September we launched a self-learning SharePoint site and we have had over 3,000 site visits since that time.
