**ORDER OF COMMITMENT TO THE
OREGON YOUTH AUTHORITY**

NOW, THEREFORE, IT IS THE ORDER OF THE COURT THAT:

- 1) The youth offender is committed to and placed in the legal custody of the Oregon Youth Authority, State of Oregon, for placement for a period not to exceed *(v) _____, but said period shall not extend beyond date on which the youth becomes 25 years of age.
- 2) Guardianship of the youth offender is granted to the Oregon Youth Authority of the State of Oregon. Oregon Youth Authority shall refer this matter to Support Enforcement Division within 5 working days and shall apply to become the representative payee for any federal benefits available to the youth and this information can be subject to computer matching.
- 3) The Director of the Oregon Youth Authority or his/her authorized representative may photograph and fingerprint the youth offender.
- 4) **Other conditions to include:**

IT IS FURTHER ORDERED THAT _____ of _____ County, State of Oregon shall cause the youth offender to be delivered to a youth correctional facility.
