


2. In general, how frequently does an incarcerated parent get visitation?


3. Who typically supervises visitation for incarcerated parents?


4. What is the typical means by which an incarcerated parent has their contact conducted with their child?


5. What is the typical length of time it takes for the Department of Correction to clear Child Welfare staff background in order to allow a first visit?
