**Nanci Thaemert** is the Director of Juvenile and Family Court Programs Division which is charged with developing, implementing, and evaluating court programs for statewide application in the Oregon courts. She has spent her entire career serving government and nonprofit entities to ensure families and children in the system are safe and free of abuse. Before moving to Oregon, Nanci spent a decade at the Idaho Supreme Court managing programs and services in the areas of family law, juvenile dependency and delinquency, domestic violence, and guardianships and conservatorships. She is an expert on guardianship reform efforts and has trained and presented on this topic across the country. Nanci holds a juris doctorate from the Willamette University School of Law and is a licensed attorney.

**Heidi Olsen Strauch** earned her BA in Political Science from Drake University and her JD from Lewis & Clark Law School. For seven years Heidi was a partner in general practice in a small-town law firm in Columbia County, encompassing both a civil practice and serving as city attorney for criminal matters, prosecuting misdemeanors in municipal court. Heidi now serves as the Juvenile Court Programs Manager for the Oregon Judicial Department.
