## Remote Child Support Mission Statement

Our goal is to ensure the fair and effective resolution of child support contempt cases through accessible remote proceedings, emphasizing children's needs and encouraging parental responsibilities. We aim to support families through an approachable court program. Offering support to overcoming barriers to payment while considering the diverse needs of all parties involved.

## PARENTAL ACCOUNTABILITY AND ENGAGEMENT PROGRAM (PAE)

The PAE program is a deferred sentencing option that is offered to those who are in contempt with an open child support case. Through this program a person will be able to:

- Talk about barriers that may be holding them back from paying child support.
- Connect with local resources and services that can help them navigate these barriers.
- Begin making child support payments that will go up over time to their monthly amount due in the child support order.
