## SPOTLIGHT

### Parental Accountability and Engagement Program (PAE Program)

PAE Coordinator – Angela Grant

The PAE Program – *pronounced 'pay program'* – is a deferred sentencing option for defendants facing a contempt charge for non-payment of child support. This program allows defendants an opportunity to earn a dismissal of their case by offering lower monthly child support payments while they are looking for work or eliminating other barriers that are preventing them from meeting their child support obligation.

In this program, participants will be able to discuss barriers holding them back and connect with local resources/services that can help with these challenges. The PAE Coordinator meets with participants remotely and around the participant's schedule.

The PAE Program assisted participants over the last several years and collected an estimated \$35,295.00 in child support payments. In December, the PAE program successfully graduated a participant after 8 months of participation and consistent payments, with his charges being dismissed.
